# Plan #007 - Montefiore Medical Center Tax Deferred Annuity 403(b) Plan

This is a summary of the annual report of the Montefiore Medical Center Tax Deferred Annuity 403(b) Plan, EIN 13-1740114, Plan #007 for the period January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Basic Financial Statement

Benefits under the plan are provided by a combination of funding arrangements. Plan expenses were \$30,833,538. These expenses included \$35,459 in administrative expenses, \$30,735,673 in benefits paid to participants and beneficiaries, and \$62,406 in other expenses. A total of 8,810 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$738,768,832 as of December 31, 2015, compared to \$719,223,299 as of January 1, 2015. During the plan year, the plan experienced an increase in its net assets of \$19,545,533. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or cost of assets acquired during the year. The plan had total income of \$50,379,071, including employer contributions of \$48,324,115 employee contributions of \$0, gains of \$0, from the sale of assets, and earnings from investments of \$4,934,447.

# Plan #008 – Montefiore Medical Center Voluntary Tax Deferred Annuity 403(b) Plan

This is a summary of the annual report of the Montefiore Medical Center Voluntary Tax Deferred Annuity 403(b) Plan, EIN 13-1740114, Plan #008 for the period January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Basic Financial Statement

Benefits under the plan are provided by a combination of funding arrangements. Plan expenses were \$73,509,807. These expenses included \$213,170 in administrative expenses, \$73,184,704 in benefits paid to participants and beneficiaries, and \$111,933 in other expenses. A total of 29,830 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,443,755,779 as of December 31, 2015, compared to \$1,387,990,297 as of January 1, 2015. During the plan year, the plan experienced an increase in its net assets of \$55,765,482. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or cost of assets acquired during the year. The plan had total income of \$129,275,289, including employer contributions of \$0, employee contributions of \$111,849,118, gains of \$0, from the sale of assets, and earnings from investments of \$11,955,080.
