

2016 SUMMARY ANNUAL REPORTS FOR THE MONTEFIORE MEDICAL CENTER BENEFIT PROGRAM

Plan #007 - The Montefiore Medical Center Tax Deferred Annuity 403(b) Plan

This is a summary of the annual report of The Montefiore Medical Center Tax Deferred Annuity 403(b) Plan, EIN 13-1740114, Plan #007 for the period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a combination of funding arrangements. Plan expenses were \$37,082,866. These expenses included \$431,856 in administrative expenses, \$37,082,866 in benefits paid to participants and beneficiaries, and \$100,524 in other expenses. A total of 8,971 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$796,907,990 as of December 31, 2016, compared to \$738,768,832 as of January 01, 2016. During the plan year, the plan experienced an increase in its net assets of \$58,139,158. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or cost of assets acquired during the year. The plan had total income of \$95,754,404, including employer contributions of \$51,116,958, employee contributions of \$0, gains of \$0, from the sale of assets, and earnings from investments of \$45,398,710.

Plan #008 - The Montefiore Medical Center Voluntary Tax Deferred Annuity 403(b) Plan

This is a summary of the annual report of The Montefiore Medical Center Voluntary Tax Deferred Annuity 403(b) Plan, EIN 13-1740114, Plan #008 for the period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a combination of funding arrangements. Plan expenses were \$82,249,701. These expenses included \$1,018,035 in administrative expenses, \$80,930,864 in benefits paid to participants and beneficiaries, and \$257,215 in other expenses. A total of 30,687 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,573,605,603 as of December 31, 2016, compared to \$1,443,755,779 as of January 01, 2016. During the plan year, the plan experienced an increase in its net assets of \$129,849,824. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or cost of assets acquired during the year. The plan had total income of \$212,099,525, including employer contributions of \$0, employee contributions of \$131,345,520, gains of \$0, from the sale of assets, and earnings from investments of \$80,576,940.

Plan #501 - The Montefiore Medical Center Employer Health & Welfare Benefit Plan

This is a summary of the annual report of The Montefiore Medical Center Employer Health & Welfare Benefit Plan, EIN 13-1740114, Plan #501 for the period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Montefiore has committed itself to pay certain dental claims incurred under the terms of the plan. The plan has insurance contracts with Principal Life Insurance Company to pay certain Life insurance, claims incurred under the terms of the plan.

Plan #503 - The Montefiore Medical Center Retiree Benefit Plan

This is a summary of the annual report of The Montefiore Medical Center Retiree Benefit Plan, EIN 13-1740114, Plan #503 for the period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Montefiore Medical Center has committed itself to pay certain hospital, surgical and major medical claims. The plan also has a contract with Express Scripts to pay certain prescription drug claims incurred under the terms of the plan.
