Plan #008 - Montefiore Medical Center 403(b) Plan

This is a summary of the annual report of the Montefiore Medical Center 403(b) Plan, EIN 13-1740114, Plan #008 for the period January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$217,885,914. These expenses included \$1,829,225 in administrative expenses and \$215,336,049 in benefits paid to participants and beneficiaries, and \$720,640 in certain deemed and/or corrective distributions. A total of 25,903 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$3,942,303,782 as of the end of the plan year, compared to \$3,462,065,613 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$480,238,169. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$698,124,083, including employer contributions of \$61,653,657, employee contributions of \$170,363,096, rollover contributions of \$10,547,596, other income of \$10,545,698 and earnings from investments of \$445,014,036.
